The Grand Teton Soaring Club (GTSC) was formed as a non-profit organization to promote safe soaring, advance the knowledge of the sport, and to provide its members with advanced gliders at minimum cost. GTSC is governed by a board of directors elected from the membership. Membership is open to all individuals interested in the sport of soaring. Application for membership in GTSC can be made at any time.

To help establish GTSC, we encourage members to contribute "seed money" above and beyond the required initiation fee. Seed money will be fully refundable, and reimbursement will be made upon request and/or when the GTSC budget allows it.

Membership categories:

Regular:

Those who have paid the Regular initiation fee and current annual dues are considered Regular Members. Regular Members are entitled to full member privileges and use of GTSC sailplanes with no hourly fee.

Family:

Members of a Regular Member's family (spouse or children). Family Members will not pay the initiation fee but will pay the regular annual dues, and are entitled to the same privileges as Regular Members.

Student:

A person enrolled full-time in Jr. High School, High School, or College. Student members pay reduced initiation fees and annual dues, and are entitled to the same privileges as Regular Members.

Associate:

Private owners of gliders may join the club for a reduced annual fee. They will have voting privileges but their use of Club gliders shall be limited to 10 hours per year.

Instructor / Tow Pilot:

Members who offer glider instruction to GTSC members or operate GTSC tow planes least two days per month during soaring season, can join GTSC with no initiation fee and no annual dues. Instructor / Tow Pilot members can operate GTSC aircraft only when providing services to members. No personal use of GTSC aircraft is permitted.

I hereby release, forever discharge, and covenant not to sue the Releasees, from all liability and responsibility, whether in tort, contract, or otherwise, for any injury, loss, or damage suffered by me in conjunction with flight related activities, including property loss or bodily injury or death, however caused, including the negligence, gross negligence or willful misconduct of the Releasees.

I hereby agree to indemnify and save harmless the Releasees from all claims, demands, actions, and causes of action by any other person, including my heirs, executors, insurers, successors and assign in consequence of any injury, loss or damage suffered by me in connection with flight activities. This Agreement binds my estate and will ensure to the benefit of the estates of the Releasees.

I have read the above and understand it. I am entering into this Waiver and Liability Exclusion Agreement of my own free will and not under duress.
